TERMS AND CONDITIONS

The Spirit of Tasmania Arts, Heritage and Tourism Award

These terms, conditions and eligibility criteria apply to individuals who have been nominated for the 2019 Tasmanian Volunteering Award listed above. Nominations close at midnight, Sunday, 10 March 2019. Finalists will be announced during the week commencing 22 April 2019, with the Awards presented on Monday, 20 May 2019.

1. Entry into Competition

All nominators agree to have read, understood and accepted the following terms, conditions and eligibility criteria before submitting a nomination.

2. Nominations

2.1 The following terms apply to nominations:

- Self-nominations are accepted
- Nominations that are late, incomplete or not received will not be accepted
- A person can be nominated for multiple Award categories, but each nomination must be submitted on a separate nomination form, and
- The activities for which nominees are being nominated for must have been carried out in a voluntary, unpaid capacity.

2.2 Submission of nominations

Nominations can be submitted by the following groups:

- Not-for-profit organisations
- Local and state government agencies
- Business groups
- Other individuals, or
- Themselves.

The nominator must know the nominee. Nominators may nominate a family member.

3. Eligibility Criteria for Nominees

Individual Nominees must meet the following requirements:

- The nominee must be residing in Tasmania
- The unpaid, voluntary activities must have occurred in Tasmania
- The volunteering activities must have occurred within the Award period of April 2018 to March 2019
- The organisation for which the nominee was volunteering must have been operating within the Award period April 2018 to March 2019, and
- The voluntary work must be for the benefit of individuals, communities and/or environments in Tasmania.

4. Eligibility Criteria for Finalists

- Three finalists will be chosen by an independent judging panel chaired by Volunteering Tasmania.
- All finalists must be able to attend the Awards ceremony, or send a representative, to be eligible.
- Staff, volunteers and immediate family members of an Awards Sponsor are eligible to submit a nomination for the Awards Category their organisation is sponsoring. For more information on the impartial judging process please visit this [page](#).

The following individuals are not eligible for recognition:

- Staff and volunteers who created and implemented these Awards and staff and volunteers of Volunteering Tasmania.
- Any immediate family member of a staff member or volunteer who created and implemented these Awards, and immediate family members of staff and volunteers of Volunteering Tasmania.

5. Condition of Entry – Copyright Notice

All nominators agree upon entering to the following conditions:

- All photography taken by Volunteering Tasmania remains the property of Volunteering Tasmania
- Photographs and information provided by the nominator to Volunteering Tasmania becomes the property of Volunteering Tasmania
- Volunteering Tasmania reserves the right to publicise, release and use any photographs or information obtained from the nominator for its own purposes, in line with the mission, values and goals of Volunteering Tasmania, Inc.
- Volunteering Tasmania is not liable for any misuse or damage that may result from the use of any photography or information provided by the nominator to Volunteering Tasmania.

6. Condition of Entry – Finalist Round

Nominees selected as potential finalists in this Award Category must agree in writing that they comply with the terms and conditions of entry (3), (4) and (5) above before progressing to the finalist round.
